## What is this product?

### Type

This is an open ended UCITS fund.

### Term

There is no maturity date of the fund.

### Investment objective

The fund aims to provide capital growth and income of 3 month Euribor + 2% before fees have been deducted\* over a three to five year period. The fund aims to provide this return with a volatility (a measure of how much the fund's returns vary over rolling 3 year periods) of 3-5% per annum. The fund aims to achieve the objective by investing in a diversified range of assets and markets worldwide that meet the investment manager's sustainability criteria.

The fund is actively managed and invests at least two-thirds of its assets directly or indirectly through derivatives in equities, bonds and alternative asset classes. Bonds include government bonds, corporate bonds, emerging market debt, sub-investment grade bonds (being bonds with a credit rating below investment grade as measured by Standard & Poor's or any equivalent grade of other credit rating agencies), convertible bonds and inflation linked bonds. The fund may invest indirectly in alternative asset classes such as commodities or real estate through derivatives, investment funds or structured securities.

The fund may (exceptionally) hold up to 100% of its assets in cash. The fund may invest up to 10% of its assets in open-ended investment funds.

The fund may use derivatives, long and short, (and total return swaps and contracts for difference) with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

**Benchmark:** The fund's performance should be assessed against its target benchmark, being 3 month EURIBOR (or an alternative reference rate) plus 2% per annum, and its volatility objective of 3-5% per annum.

The investment manager invests on a discretionary basis and is not limited to investing in accordance with the composition of a benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. ### Other Information

The fund maintains a higher overall sustainability score than a bespoke asset weighted blend\* of MSCI World Index (hedged to EUR), FTSE World Government Bond Index (hedged to EUR), MSCI Emerging Market Index (hedged to EUR), Barclays Global Aggregate Corporate Bond Index (hedged to EUR), Barclays Global High Yield excl CMBS & EMD 2% Index (hedged to EUR), ICE BofA US Treasury Index (hedged to EUR), JPM GBI Emerging Market Index - EM Local (hedged to EUR), JPM EMBI Index EM Hard Currency (hedged to EUR), Thomson Reuters Global Convertible Bonds Index (hedged to EUR), based on the investment manager's rating system. \*The blend will evolve over time in line with the actual asset allocation of the fund.

**Dealing Frequency:** You may redeem your investment upon demand. This fund deals daily.

**Distribution Policy:** This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

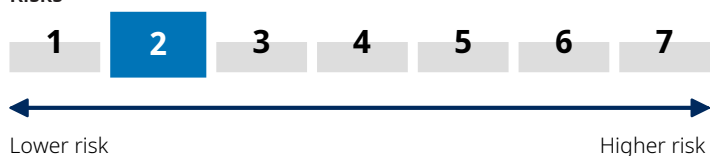

### Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. ## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

## What are the costs?

### Costs over time
