What is this product?

Type

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide capital growth in excess of 3-month USD T-Bills +3% per annum before fees have been deducted* over a three to five year period by investing in a diversified range of assets and markets worldwide.

The fund is actively managed and invests in asset classes including, but not limited to, equities, bonds, currencies and commodities, in order to provide exposure to long and short strategies. The fund will focus on momentum strategy, which attempts to take advantage of the tendency for recent price trends to continue.

The fund is managed to maintain a balanced exposure between long and short positions (gained through derivatives). The fund may invest in bonds that have a sub-investment grade credit rating (as measured by Standard & Poor's or any equivalent grade of other credit rating agencies). The fund may also gain exposure to alternative asset classes including commodities.

The fund may hold substantial levels of cash (exceptionally this may represent 100% of the fund's assets). The fund may also invest in open-ended investment funds.

The fund may use derivatives (including total return swaps) with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

Benchmark: The fund's performance should be assessed against its target benchmark, being to exceed 3-month USD T-Bills +3% per annum, and compared against 3 month USD T-Bills. Please see appendix III of the fund's prospectus for further details.

Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.

Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. Performance Scenarios
